Commissioner Nelson called the meeting to order with all members and the County Clerk present. Minutes of the December 12, 2017 were read. Commissioner Nelson made motion to approve minutes. Commissioner Hofstetter seconded the motion. Motion carried 3-0.

Appraiser

Mark Niehaus, County Appraiser, discussed Industrial Park. Also updated the Commissioners on taxpayer's concern with taxes.

Sheriff

Cole Presley, Sheriff, arrived at this time and discussed dispatching fees. No action taken.

Extension

Karen Shepard, FACS, reported on activities the Extension council has been involved in. Keys to Embracing Aging program, Family Nutrition Grant, Stay Strong, Stay Healthy, 4-H and Youth Quilt of Valor. Karen reported the new Ag Agent will start on January 2. Operational agreement with Twin Creeks was approved and signed by Commissioners.

Miscellaneous

Diana Crouch, Lindsey Thompson, Lindsey Bryant, Zach Thompson, Ty Hockman, and Tawny Ashbaugh were all present to discuss Growing Graham County. I was agreed this program will start January 1, 2018.

Health

Michelle advised she is working on a Medicare revalidation and will need the Commissioners signature.
